FEES

The School year is divided into 2 Tuition Periods: September to January and February to June. The onetime non-refundable admission fee, refundable book deposit, break down of tuition fees and fees for optional services are clearly listed in the fee schedule. Details regarding wire transfers, sibling discounts and refund policies are clearly explained.

Pro Rating of Tuition Fees

Tuition fees will be prorated for students who are admitted after the start of the tuition period. Tuition fees will be pro-rated as per the calendar month.

Late Fees and Non Payment of Fees

All fees must be paid on/by the date stipulated on the **INVOICE**. Late payments will be subject to interest charges.

All accounts that continue to carry a balance after the commencement of the first tuition period will be charged a finance fee of 15% per annum, compounded daily until fees are fully paid.

When the second tuition period commences, accounts that have not been paid in full, 2 weeks prior to commencement of 2nd tuition period will attract a finance fee.

This is to ensure continued enrollment of your child at CIS.

CIS reserves the right to suspend or withdraw students, and to withhold the release of school reports, transcripts, recommendation letters and others documents, if school fee obligations are not fulfilled.
